## Introduction

The present World Skate Europe Rulebook shall be applicable to all the Track Series Europe Events, special circumstances can modify some of its articles on the basis of specific local venue characteristics where the Stage takes place, only under authorisation and supervision from World Skate Europe.

Participation in a stage of Track Series Europe, in whatever capacity, shall imply acceptance of all provisions of the Regulations applying thereto. In these Regulations the masculine gender is used, for no other reason than simplicity, in relation to any physical person. It is a mere formality to indicate both the feminine and masculine gender. The word “skater” means any man or woman practicing the Speed discipline governed by the present Regulations.

The present Technical Regulations Rulebook is the Official version, written in the Official World Skate language: English. In the event of divergence between different versions of the present Regulations, the original text in its original language shall prevail.

## Definitions

The Track Series Europe is an official European series of the World Skate Europe.

This series has its own regulations and applies the WS technical rules.

There are two levels of the Track Series Europe: the “Speed Track European Series” and the “European Track Challenge”.

## Speed Track European Series

The Speed Track European Series is the first level of the Track Series Europe.

In the Speed Track European Series there are 5 (five) stages. There is only one stage per country.

At the end of each stage, the delegate of the WSE Technical Commission will draw up an evaluation document of the same.

To be included in the five stages, each interested organizer must make a specific request using the attached form (annex 1)

Each year the five stages will be chosen by the Speed Technical Commission of World Skate Europe evaluating:

- the data contained in the request for the assignment of a Speed Track European Series stage;
- the evaluation document drawn up by the delegate of the Technical Commission at the end of each stage of the previous year.

The request for the assignment of a Speed Track European Series stage must be received by World Skate Europe by 30 April of the previous year (for the year 2025 by 31 October 2024) using the attached form.

Every year the timetable for the 5 stages of the Speed Track European Series will be defined by the WSE Technical Commission.

### 1. Duration

Days of competition: three (maximum) for each event.

### 2. Participation

- All European skaters authorized by their corresponding National Federation which is affiliated to the World Skate Europe;
- When registering, European athletes must be given priority over athletes from other continents;
- All skaters from other Continental Federations affiliated with WS may participate in the Speed Track European Series (on invitation by the organizers)

Participants may find details for entries on the World Skate Europe website (link to each organizer/website);

- central registration;
- unique TSE ID;
- Fees to be paid by bank transfer as indicated.

### 3. Categories

Categories: Cadet, Youth, Junior and Senior.

### 4. Event Organization

1. Organizers are authorized to use the World Skate Europe logo and must hoist the World Skate Europe flag in the sports venue.
2. The WSETC will attend every event with its own delegate, being the Travel, board and lodging expenses up to the local organizer.
3. Board and lodging expenses of other World Skate Europe attending members will be responsibility of the Technical Commission.
4. An official representative of the national federation of organizer country has to be present at the stage.
5. Insurance: each participant must have his own personal insurance. At the same time, organizers too must have a third party insurance against third party.
6. Website: each organization must have its own website containing details about the event (proper application with entries, hotels, features of the track, modalities of entries, type of races, etc.).
7. The World Skate Europe provides a template for the announcement of the stage. The template must be used by the organizer (unity of announcements and in accordance with the rulebook).
8. The Speed Track European Series races/categories have preference/priority. It is not possible to cancel Speed Track European Series races and instead to start races of non-Speed Track European Series categories.
9. The official distances of the Sports Rules have to be chosen for European Cup short/long distances.
10. The award ceremony must be started on Sunday within 6 pm (this is the latest moment).
11. If any skater cannot participate at the award ceremony he must announce this to the Technical Commission member present at this stage.
12. If the skater does not participate in the ceremony, he will lose all his points from this event.

## 5. Ranking

**Data:** Before, during and at the end of the event, all data must be sent to the World Skate Europe Technical Commission.

**Rankings:** Separate rankings for short distance and long distance races will be prepared after each event. A skater may participate in short and long distance races (no rankings per team).

Points will be assigned as follows: 30 points to the 1<sup>st</sup> skater, 29 points to the 2<sup>nd</sup> one, 28 points to the 3<sup>rd</sup> one, and up to 15<sup>th</sup> place 26/24/22/20/18/16/14/12/10/8/6/4;

2 points to all the other ranked skaters.

If skaters have the same amount of points in the stage ranking, the winner is the skater who was in the better position/ranking in the last distance.

**Final ranking:** Each skater must participate in at least one (1) events if he wants to take part in the overall ranking. For the final ranking, all the results achieved will be considered.

In each stage there will be two short distance races and two long distance races. Each organizer can freely choose two of the three official short distance races.

## 7. Prize money

1. In order to increase the prize money, organizers will do their best in looking for sponsors, with the assistance of Technical Commission.
2. This matter will be coordinated by the Technical Commission with the organizers.
3. Prize money has to be claimed personally by the qualified skaters on the official Technical Commission form (declaration of tax) and has to be sent to Technical Commission.
4. Unclaimed prize money will be put in the prize money of the following year.
5. For the prize money there will be no ex aequo.

If skaters have the same amount of points in the final ranking, the winner is the skater who was in the better position/ranking in the last stage (first criteria), in the stage they all have taken part (second criteria).

6. The payment will be made by World Skate Europe by bank transfer after the last stage.

## 8. Medals

The World Skate Europe will supply medals for the first 3 skaters of each ranking/category in the tournament. The cost of the medals and the payment of the prize money is up to the World Skate Europe. There will be no medals given for the final ranking of the overall tournament.

## 9. Organizer fee

An organizing fee of 5.000,00 euro has to be paid to World Skate Europe at least by 31 January of each year with all the corresponding documents. The major part of this sum will create prize money to be assigned on the basis of the final ranking.

## 10. Inscription fee

An inscription fee of 50,00 euro has to be paid to the organizer of the stage.

## 11. Technical rules

The World Skate Europe rules will be applied.

## 12. Event composition

Types of races:

Competitions must schedule, in each event, two (2) sprint races and two long distance races. Every day, there will be one short distance race and one long distance race.

Races cannot be changed during the running of the event; in case of adverse weather conditions, rankings can be made on one race only.

Each organizer may decide for any other category (outside of the Speed Track European Series), like Masters or Beginners.



### **13. Judges**

The Technical Commission will send to each organization the list of the, with the name of the Chief Referee

The jury must include five international judges of different nationalities.

The organizers must pay boarding, lodging and travel expenses of judges. Special arrangements are possible.

### **14. Technical equipment**

Each organizer must have:

- Homologated Track;
- Coated track;
- high level timekeeping with a photo finish system;
- live streaming with pro graphics;
- digital results board;
- big screen;
- speaker in English.

### **15. Anti-doping rules**

WADA Code, World Skate antidoping Rules, WADA International Standards for Testing and Investigation, WADA international standards for results Management, World Skate TDP will be observed for the sample collection process and laboratory analysis.

## European Track Challenge

The European Track Challenge is the second level of the Track Series Europe.

In the European Track Challenge there are 4/5 (four/five) stages. It is possible to have more than one stage per country.

At the end of each stage, the delegate of the WSE Technical Commission will draw up an evaluation document of the same.

To be included in one of the European Track Challenge stages, each interested organizer must make a specific request using the attached form (annex 2)

The request for the assignment of a European Track Challenge stage must be received by World Skate Europe by 30 April of the previous year (for the year 2025 by 31 October 2024) using the attached form.

Every year the timetable for the 5 stages of the European Track Challenge will be defined by the WSE Technical Commission.

### 1. Duration

Days of competition: three (maximum) for each event.

### 2. Participation

- All European skaters authorized by their corresponding National Federation which is affiliated to the World Skate Europe;
- All skaters from other Continental Federations affiliated with WS may participate in the Euro Cup (on invitation by the organizers)

Participants may find details for entries on the World Skate Europe website (link to each organizer/website);

- central registration;
- unique TSE ID;
- Fees to be paid by bank transfer as indicated.

### 3. Categories

Categories: Cadet, Youth, Junior and Senior.

#### 4. Event Organization

1. Organizers are authorized to use the World Skate Europe logo and must hoist the World Skate Europe flag in the sports venue.
2. The WSESTC will attend every event with its own delegate, one (1) delegate at the final event, being the travel, board and lodging expenses up to the local organizer.
3. Board and lodging expenses of other World Skate Europe attending members will be responsibility of the Technical Commission.
4. An official representative of the national federation of the organizer country has to be present at the stage.
5. Insurance: each participant must have his own personal insurance. At the same time, organizers too must have a third party insurance against third party.
6. Website: each organization must have its own website containing details about the event (proper application with entries, hotels, features of the track, modalities of entries, type of races, etc.).
7. The World Skate Europe provides a template for the announcement of the stage. The template must be used by the organizer (unity of announcements and in accordance with the rulebook).
8. The European Track Challenge races/categories have preference/priority. It is not possible to cancel European Track Challenge races and instead to start races of non-European Track Challenge categories.
9. The official distances of the Sports Rules have to be chosen for European Track Challenge short/long distances.
10. The award ceremony must be started on Sunday within 6 pm (this is the latest moment).
11. If any skater cannot participate at the award ceremony he must announce this to the Technical Commission member present at this stage.
12. If the skater does not participate in the ceremony, he will lose all his points from this event.

#### 5. Ranking

**Data:** Before, during and at the end of the event, all data must be sent to the World Skate Europe Technical Commission.

**Rankings:** Separate rankings for short distance and long distance races will be prepared after each event. A skater may participate in short and long distance races (no rankings per team).

Points will be assigned as follows: 30 points to the 1st skater, 29 points to the 2nd one, 28 points to the 3rd one, and up to 15th place 26/24/22/20/18/16/14/12/10/8/6/4; 2 points to all the other ranked skaters.

If skaters have the same amount of points in the stage ranking, the winner is the skater who was in the better position/ranking in the last distance.

3. Prize money has to be claimed personally by the qualified skaters on the official Technical Commission form (declaration of tax) and has to be sent to Technical Commission.
4. Unclaimed prize money will be put in the prize money of the following year.
5. For the prize money there will be no ex aequo.

If skaters have the same amount of points in the final ranking, the winner is the skater who was in the better position/ranking in the last stage (first criteria), in the stage they all have taken part (second criteria).

6. The payment will be made by World Skate Europe by bank transfer after the last stage.

The Technical Commission will send to each organization the list of international judges, with the name of the Chief Referee

The jury must include two international judges.

The organizers must pay boarding, lodging and travel expenses of judges. Special arrangements are possible.

### **14. Technical equipment**

Each organizer must have:

- Homologated Track;
- Coated track;
- high level timekeeping with a photo finish system;

Not mandatory:

- live streaming with pro graphics;
- digital results board;
- big screen;
- speaker in English.

2. copy of the document of the legal representative;
3. external and internal photos of the plant;
4. map of the facility with indication of the areas used for the preparation of the athletes;
5. listed map of the race track;
6. Communication plan.

In addition, the application must be accompanied by a descriptive project that presents, as a whole, the organization of the Event, including any collateral or parallel initiatives that you intend to organize.

The organizer participating in the tender may attach to the application any additional material (paper, photographic, video) useful to better describe the proposed solution.



## **General provisions of the organizer**

### **Organizer fee**

An organizing fee of 5.000,00 euro has to be paid to World Skate Europe at least by 31 January of each year with all the corresponding documents. The major part of this sum will create prize money to be assigned on the basis of the final ranking.

Failure to pay the fee within the deadline will result in the forfeiture of the assignment of the organization of the Event.

Cancellation of the Event after January 31st will result in the forfeiture by World Skate Europe of the fee paid.

### **Minimum Plant Requirements**

The track must be homologated and comply with the rules of World Skate Europe.

### **Minimum services and logistics requirements required**

The Organizer undertakes to:

1. carry out, with its own autonomy of means and people, the operations related to the organization and promotion of the event and activities related to the event;
2. arrange for the arrangement of the system;
3. provide an adequate room for the health service, the assured presence of a doctor and two ambulances with paramedical staff;
4. set up, for anti-doping control, a special room adjacent to the competition facility, equipped with toilets;
5. ensure a high level timekeeping with a photo finish system;
6. set up a rain-proof stand for the secretariat of the Jury; this stand must be equipped with lighting, power sockets, a socket for internet connection and must be positioned outside the track together with the Jury;
7. provide, where possible, a possible area or a path adjacent to the race course, with suitable flooring for the athletes' pre-race technical warm-up;
8. Ensure a speaker in English;
9. Ensure that the clothing worn by service personnel is decent and above all homogeneous, easily identifiable (T-shirts, caps, etc.);
10. Follow, for what is not reported, the Track Series Europe Rulebook of World Skate

Europe.

### **Marketing & Communication Services & Requirements**

The Organizer shall ensure:

1. The availability of promotional spaces for the World Skate Europe Logo and must hoist the World Skate Europe flag in the sports venue
2. A proper live streaming service with Pro Graphics
3. The availability of a digital results board;

### **Minimum services and logistics requirements required**

The Organizer undertakes to:

11. carry out, with its own autonomy of means and people, the operations related to the organization and promotion of the event and activities related to the event;
12. arrange for the arrangement of the system;
13. provide an adequate room for the health service, the assured presence of a doctor and two ambulances with paramedical staff;
14. set up, for anti-doping control, a special room adjacent to the competition facility, equipped with toilets;
15. ensure a high level timekeeping with a photo finish system;
16. set up a rain-proof stand for the secretariat of the Jury; this stand must be equipped with lighting, power sockets, a socket for internet connection and must be positioned outside the track together with the Jury;
17. provide, where possible, a possible area or a path adjacent to the race course, with suitable flooring for the athletes' pre-race technical warm-up;
18. Ensure a speaker in English;
19. Ensure that the clothing worn by service personnel is decent and above all homogeneous, easily identifiable (T-shirts, caps, etc.);
20. Follow, for what is not reported, the Track Series Europe Rulebook of World Skate Europe.

5. The availability of promotional spaces for the World Skate Europe Logo and must hoist the World Skate Europe flag in the sports venue
